The Coalition wishes to express its heartfelt sympathy to the family and friends of those who lost their lives at Pulse in Orlando on June 13. We salute all those who responded to the attack, the deadliest mass shooting event in U.S. history. The Coalition stands ready and continues to provide resources to the City of Orlando and Orange County as we transition from response to recovery.

## **2016 Provides Learning Opportunities**

The first six months of 2016 have been challenging but have provided many learning opportunities to the Coalition and its members. These include:

January through May - ICAR Project (Infection Control & Response). The Coalition provided two frontline hospital training programs, completed eight assessment hospital site visits and 25 frontline hospital site visits, completed an inventory of EMS capabilities, drafted a resource coordination plan, partnered with DOH-Orange to host a highly

infectious disease tabletop, and met with coalition stakeholders to identify priorities to closing gaps in responding to highly infectious diseases.







March - Annual Regional Hospital Exercise: The School Daze exercise participants included the Coalition, fifteen

hospitals and the VA, and more than 600 students as victim volunteers to test medical surge capabilities. Burger King and the Salvation Army partnered with the Coalition to provide feed the victim volunteers.

# **Learning Opportunities - Continued:**

May Invictus Games in Orlando. The State Medical Response Team 5 regularly partners with local entities to provide support at mass gatherings to augment local capabilities, such as the Disney marathons, Daytona 500, airshows, etc. The Reedy Creek Fire Rescue invited SMRT 5 to be on standby to provide medical surge (including triage and transport) in the event of a mass casualty during the Invictus Games. During this five day event, more than 500 Paralympic athletes from 15 nations competed at the Walt Disney ESPN Wide World of Sports complex. Dignitaries included Prince Harry, President George Bush, Vice President Joe Biden and First
